ORDER

INFORMATION TECHNOLOGY ACT, 2000.

No. DIT/FILE/03/II/335.—Whereas under Government Notification No. DIT/FILE/ 03/I/335, dated the 7th August 2003 issued under sub-section (1) of section 70 of the Information Technology Act, 2000 (21 of 2001),(hereinafter referred to as " the said Act ") the Government has declares the computers, computer systems and the computer networks mentioned in the schedule appended to the said Notification, to be a protected system ;

And whereas it is necessary to authorise certain persons under sub-section (2) of section 70 of the said Act, to access protected systems notified under the said Notification ;

Now, therefore, in exercise of the powers conferred by sub-section (2) of section 70 of the said Act, the Government of Maharashtra hereby authorises the persons mentioned in column (3) of the Table below to access the protected systems respectively mentioned against the said persons in column (2) thereof.
